

EU research and innovation in 30 years

- R&I from a piece of industrial policy to a genuine EU policy
- E. Davignon: FP has shown the vanity of national borders
- A key EU policy for several President Juncker priorities: growth and jobs, digital single market, Energy Union, strengthened industrial base
- For 2014-2020 (MFF): €280 Billion for R&I (Structural and Investment Funds and Horizon 2020)
- ERC, Joint Programming, EIT, ERA
- But sill a lot to do if Europe wants to be a global R&I leader
